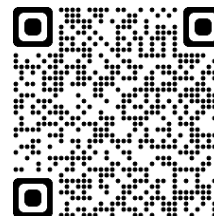

We demand an election of a successor to that office.

The grounds for the recall are as follows: The board failed the students by not advocating for a return to school as soon as the guidelines allowed. The board repeatedly failed to reopen all schools when allowed by the state, while other districts within our county reopened several months sooner than LMUSD. The district could have reopened as early as October 6, 2020 but did not begin opening in a hybrid format until March 2021. In November, the board failed to seek a waiver for elementary schools to reopen and continued to refuse to open all schools full-time when the CDPH guidelines were updated to allow for full-time, in person learning on March 20, 2021. In addition to these failures, Martin has introduced political comments into the public school board meetings, thus distracting from the bipartisan purpose of the board. Martin has also blamed parents for low achievement instead of accepting responsibility for the board's actions, which have resulted in low student performance. Failing grades were up 155% at the high school level at the end of the first semester, largely due to the actions of the board. Lastly, Martin has dismissed failing students as not worth the effort since they are 'not college bound'.
